Title (mandatory by originator): Amendment of SVAA Service Line SSL330 to bring it in line with current contract arrangements.

Description of Problem/Issue (mandatory by originator)

Changes to the Supplier Volume Allocation Agent (SVAA) contract arrangements have created a misalignment between the contract arrangements and the SVAA Service Line SSL330. This has necessitated amendments to SSL330 to bring it in line with the existing contract arrangements. The main areas of misalignment include the ad-hoc reporting service and the acceptance testing service requirements.

Proposed Solution (mandatory by originator)

It is proposed that the SVAA Service Line SSL330 is updated.

The amendments to SSL330 include that the:

- Ad Hoc Reporting Service will no longer be in use;
- SVAA Agreement has been replaced with the SVAO (Supplier Volume Allocation Operations) Agreement;
- Initial Settlement and Reconciliation Agent (ISRA) System has been replaced by ISRA Software; and
- Software Acceptance testing has been replaced by User Acceptance Testing.

Note that as this is a Category 2 Configurable Item, no red line changes have been provided as part of this CP.

Justification for Change (mandatory by originator)

Following the amendments to contract arrangements, it has been identified that the wording in SSL330 is out of date. This needs to be aligned to ensure that there is no potential for the SVAA to misinterpret their obligations and that there is not conflicting requirements on the SVAA.

Yes, the CP will enhance facilitation of the current Code provisions.
