

Change Proposal – BSCP40/01	CP No: 1176 <i>Version No: 1.0</i>
Title Additions to the February 2007 Release Housekeeping changes – removal of workflow diagrams from BSCPs	
Description of Problem/Issue: At its meeting on the 8 June 2006 (115/08) the BSC Panel agreed to the principles of the new Code Subsidiary Document (CSD) architecture. Part of the proposed changes included the removal of all workflow diagrams from Balancing and Settlement Code Procedures (BSCPs). It was agreed that the removal of the diagrams would take place on an ongoing opportune basis rather than as one single piece of work. CP1176 therefore proposes to remove the workflow diagrams from the relevant BSCPs, on an ongoing basis, as part of an opportune Release.	
Proposed Solution(s) As part of the February 2007 BSC Systems Release the following BSCPs are impacted: <ul style="list-style-type: none"> • BSCP27 ‘Technical Assurance of Half Hourly Metering Systems for Settlement Purposes’; • BSCP70 ‘Qualification Testing for Parties and Party Agents’; • BSCP502 ‘Half Hourly Data Collection for SVA Metering Systems Registered in SMRS’; • BSCP504 ‘Non Half Hourly Data Collection for SVA Metering Systems Registered in SMRS’; • BSCP507 ‘Supplier Volume Allocation Standing Data Charges’; • BSCP509 ‘Changes to Market Domain Data’; • BSCP514 ‘SVA Meter Operations for Metering Systems Registered in SMRS’; and • BSCP520 ‘Unmetered Supplier Registered in SMRS’. CP1176 proposes to remove the workflow diagrams from these impacted documents and remove workflow diagrams from the remaining BSCPs as part of a Housekeeping CP in a later opportune Release.	
Justification for Change The Panel has agreed that workflow diagrams should be removed from BSCPs. The above BSCPs are already impacted by CPs which have been included in the scope of the February 2007 BSC Systems Release.
