Title <i>(mandatory by originator)</i> Inconsistency within BSCP502 'Half Hourly Data Collection for SVA Metering Systems Registered in SMRS'	
Description of Problem/Issue <i>(mandatory by originator)</i> BSCP502, steps 3.2.4.8 and 3.2.7.8 state 'Request up to 14 months history data, where available, including the final Meter register reading by the old HHDC and the last physical Meter register reading taken on site, for estimation purposes' within the Interface and Timetable section. The corresponding text boxes within the workflow diagram section (processes 2.2.4 and 2.2.7) state 'Request up to 3 months history data'. Steps 3.2.4.8 and 3.2.7.8 were amended as part of the SVA May Documentation Batch Release under CP873 'Changes to the Half Hourly Data Estimation Requirements within Code Subsidiary Documents'. The workflow diagram text boxes were not updated at the same time.	
Proposed Solution(s) <i>(mandatory by originator)</i> Make a change to BSCP502 to bring the text boxes in workflow diagrams 2.2.4 and 2.2.7 in line with the corresponding Interface and Timetable steps 3.2.4.8 and 3.2.7.8 i.e. change the text boxes to read 'Request up to 14 months history data, where available, including the final Meter register reading taken by the old HHDC and the last physical Meter register reading taken on site'.	
Justification for Change <i>(mandatory by originator)</i> On a change of Half Hourly Data Collector (HHDC), the new HHDC can request history data from the old HHDC for estimation purposes. The current inconsistency within BSCP502 may lead to confusion regarding the amount of history data which should be requested and therefore can be sent.
