Title <i>Inclusion of UMS Operational Data in MDD</i>	
<p>Description of Problem/Issue <i>(mandatory by originator)</i></p> <p>The approval of CP1083 removed the Unmetered Supplies (UMS) Operational Details from BSCP520 and placed them in a new document, not included in the Baseline Statement. This made updating these details easier and more cost effective as they were no longer subject to BSCP40 Change Management processes.</p> <p>However, this change also served to further reduce visibility of changes to those market participants without representation on the UMSUG. Without such representation, market participants have limited opportunity to comment on the recommendations of the UMSUG until after a decision has been made.</p>	
<p>Proposed Solution(s) <i>(mandatory by originator)</i></p> <p>The Unmetered Supplies Operational Data should be included in Market Domain Data.</p> <p>While this proposal does not suggest that this data be added to the MDD Database, it does seek to have proposed changes incorporated in the MDD Impact Assessment Circular. As with the treatment of GSP group Profile Class Default EACs, any approved updates would then be incorporated in the next release of MDD. However, they would not be added to any DTC data flow, but would remain in the existing document format and held on the BSCCo website.</p> <p>MDD Circulars should, therefore, refer participants to the location of the Operational Data document on the website and the subsequent MDD release would simply see the document being updated, at that location.</p> <p>Following implementation of this proposal, any approved update to the UMS Operational Data should be treated as a 'General Update to MDD' for the purposes of BSCP509, and the 'UMS Operational Data' should be added to the list of MDD Entities in Appendix 4.1 to that document.</p> <p>Reference to these new arrangements will also be needed in BSCP520; in particular, Sections 1.2.5 and 1.3.1 will need to be changed to reflect them.</p>
