Title (mandatory by originator) Interconnector Administrator Data Flows

Description of Problem/Issue (mandatory by originator)

The Interconnector Administrator (IA) is required under the BSC to submit a file of Deemed Metered Volumes within 2 working days of the Settlement Day for the Interconnector concerned. This requires the IA to have the necessary Interconnector BM Unit Registration details.

Currently, there is no provision within the IDD to provide the IA with this BM Unit Registration data and therefore the IA currently relies upon the party registering the BM Units to provide the necessary information. To enable the IA to fulfil its role, it is important that formal notification of Interconnector BM Unit registration is provided.

This Change Proposal seeks to address the issue by requesting that ELEXON notify the relevant IA, via email, of changes to BM Unit registration details (i.e. details of newly registered Interconnector BM Units and details of de-registrations of existing Interconnector BM Units).

Proposed Solution(s) (mandatory by originator)

Email from ELEXON to the relevant IA providing the following data for newly registered Interconnector BM Units:

BSC Party BSC Party ID

Interconnector Production BM Unit ID Interconnector Consumption BM Unit ID

Effective Date

In addition, ELEXON shall provide the relevant IA, via email, notification of the de-registration of Interconnector BM Units and the effective data of any such de-registration.

For the avoidance of doubt, the proposed solution <u>would not include</u> notification of changes in the DC or GC values of existing Interconnector BM Units.
