Title <i>(mandatory by originator)</i> Interconnector Administrator Data Flows								
Description of Problem/Issue <i>(mandatory by originator)</i>								
<p>The Interconnector Administrator (IA) is required under the BSC to submit a file of Deemed Metered Volumes within 2 working days of the Settlement Day for the Interconnector concerned. This requires the IA to have the necessary Interconnector BM Unit Registration details.</p> <p>Currently there is no provision within the IDD to provide the IA with this BM Unit Registration data and therefore the IA currently relies upon the party registering the BM Units to provide the necessary information.</p> <p>To enable the Interconnector Administrator to fulfil its role it is important that formal notification of Interconnector BM Unit registration is provided from the Central Registration Agent (CRA).</p> <p>This Change Proposal seeks to address this issue by requesting that the CRA notify the relevant IA, via email, of changes to BM Unit registration details (i.e. changes to the details of existing Interconnector BM Units, details of newly registered Interconnector BM Units and de-registrations of existing Interconnector BM Units).</p>
