Title <i>(mandatory by originator)</i> Additional Changes to BSCP509 ‘Changes to Market Domain Data’ following implementation of the Operational Review	
Description of Problem/Issue <i>(mandatory by originator)</i> <p>CP923 ‘Operational Review of BSCP509 ‘Changes to Market Domain Data’ was implemented on 27 November 2003. Following the implementation of CP923, the Supplier Volume Allocation Agent (SVAA) has identified two issues with BSCP509:</p> <ol style="list-style-type: none"> 1. The Market Domain Data (MDD) Go Live Date is defined as ‘last date after the Publication Date by which the new version of MDD should be implemented’ and MDD Publish defined as ‘refers to the distribution of all MDD flows by the SVAA to MPs [Market Participants]...’ The term publication has been used incorrectly in two instances in section 1.3 ‘Use of the Procedure’ where reference is made to the publication being delayed. This is confusing wording as MDD will have already been published and distributed by this time. The Go Live Date should in these cases be delayed. 2. Workflow diagram 2.4 ‘Agree Implementation, Publication and Release Schedule’ is inconsistent with the corresponding Interface and Timetable section, 3.4. Reference 3.4.5 in section 3.4 shows that the MDD Circular is sent to the SVAA but this is not represented in the associated workflow diagram. 	
Proposed Solution(s) <i>(mandatory by originator)</i> <p>Make the following changes to BSCP509:</p> <ol style="list-style-type: none"> 1. The word ‘publication’ should be replaced by ‘Go-Live Date’ as follows: Section 1.3, second bullet point: ‘MPs have 2 Working days from the receipt of the MDD to contact BSCCo if they believe that the change to MDD as notified is not as agreed or invalid. If BSCCo determines that the MDD publish is not as agreed, <u>the Go-Live Date publication</u> will be delayed², and notice will be given of the revised details of the next publication in accordance with this BSCP.’ Footnote 2 ‘Delaying the <u>Go-Live Date publication</u> of Balancing Mechanism (BM) Unit(s) must not jeopardise the MPs’ ability to load the BM Unit(s) prior to the BM Unit Effective From Date.’ 2. Amend the workflow diagram in section 2.4 to show that the MDD circular sent in step 3.4.5 is also sent to the SVAA.
