Update of Supplier Meter Registration System (SMRS) database by Public Distribution System Operator (PDSO) / Supplier

Description of Change (mandatory by originator)

The Master Registration Agreement (MRA) has been amended to include a tighter description of the timescale that the PDSO and the Supplier are required to adhere to in updating the SMRS database.

BSCP501 "Supplier Meter Registration Service", which details the procedure for updating the SMRS database, needs updating to reflect this change.

Proposed Solution(s) (mandatory by originator)

The following changes are required to BSCP501 Section 3.2 'Update of SMRS Database by Public Distribution System Operator':

- 1) Ref. 3.2.1 (WHEN) Within 5WD of the latest of the Effective from Dates, provided by the Supplier, for Profile Class Id, Meter/Timesheet Code and SSC Id change taking effect or PDSO becoming aware of the change. As soon as possible and in any event within 5 WD of (i) the effective date of the change; or (ii) receiving notification that a change is required if this occurs after the effective date of the change.
- 2) Ref. 3.2.1 (**ACTION**) Provide changes to MS data, excluding Metering Point Address and Metering Point Postcode⁸, made by PDSO.
- 3) Ref. 3.2.4 (WHEN) Upon Successful validation and within 1 WD of 3.2.2 above
- 4) Ref. 3.2.5 (WHEN) Within 1 WD of 3.2.4 above
- 5) (Footnote to Section 3.2) 10 If updating Metering Point Address and/or Metering Point Postcode refer to the timescale as defined in the MRA.

The text above is consistent with the amendments made to the original version of the MRA following implementation of MRA CP78.

The following changes are also required to BSCP501 Section 3.3 'Update of SMRS Database by Supplier':

- 6) Ref. 3.3.1 (WHEN) within 5WD of the Supplier being aware of the change⁸. As soon as possible and in any event within 5 Working Days of (i) the effective date of the change; or (ii) receiving notification that a change is required if this occurs after the effective date of the change^{9, 10}.
- 7) (Footnote to Section 3.3) 9 If the effective date of the change is before the current effective date contained in the SMRS, the Supplier will apply the retrospective rules.

The text above is consistent with the amendments made to the original version of the MRA following implementation of MRA CP97.

Justification for Change (mandatory by originator)

Following the implementation of MRASCo Change Proposal No.78, an inconsistency has occurred between the MRA and BSCP501 in their description of the procedure for updating the SMRS Database. To avoid confusion between the documents, BSCP501 needs to be amended to bring it into line with the updated MRA.
