# Change Proposal – F40/02 (Page 1 of 2)

CP No: 694 (mandatory by BSCCo)

**Title** (mandatory by originator)

Remove the inconsistency in Party Service Line PSL130 in relation to the amount of data that should be transferred.

# **Description of Change** (mandatory by originator)

Modify PSL130 'Half Hourly Data Collection' so that it is self consistent and is also consistent with BSCP502 'Half Hourly Data Collection for SVA Metering Systems Registered in SMRS' in relation to how much data is transferred. The HHDC should transfer up to 3 months of the most recent metering data in accordance with clause 1.3.2.3 and also in accordance with step 3.2.4.7 of BSCP502.

#### **Background**

Problem Management Record (PMR) 24115 has identified an inconsistency in PSL130.

# **Proposed Solution(s)** (mandatory by originator)

There are three clauses in PSL130 which are impacted - 1.3.2.2, 1.3.2.3 and 5.1.9. However to minimise the potential for further inconsistencies to be introduced, it is proposed that only one clause exists in Section 1 which refers to the time period, with clause 5.1.9 cross-referencing this Section 1 clause.

### 1. Clause 1.3.2.2

Modify the last sentence of this clause so that is specifically relates to a Supplier ceasing to be responsible for the Metering System coincidentally with the HHDC. In this circumstance the requirement will be for the HHDC to immediately transfer data and other information to the Panel.

#### 2. Clause 1.3.2.3

This clause needs modifying in two ways:

- a) It should specifically exclude a Supplier ceasing to be responsible for the Metering System coincidentally with the HHDC, as this is covered in clause 1.3.2.2.
- b) It should refer to BSCP502 for the period of data to be transferred.

#### 3. Clause 5.1.9

Modify the clause so that the transfer of data will occur in accordance with clause 1.3.2.2 and 1.3.2.3.

There may be an impact on:

- → HHDCs; and
- Suppliers

## **Justification for Change** (mandatory by originator)

Clause 1.3.2.2 of PSL130 requires an immediate transfer of data to the incoming HHDC and additionally to the Panel (for a coincident Supplier ceasing to be responsible for the Metering System). Clause 1.3.2.3 of PSL130 requires up to three months of data to be transferred. Clause 5.1.9 of PSL130 requires 2 years of data to be transferred.

#### **Ensures:**

- 1. that the PSL reflects the working practices and the requirement specified in BSCP502.
- 2. that HHDCs and Suppliers are clear on their obligations in this area.
- 3. that the period of data to be transferred is documented once which minimises the risk of the document becoming inconsistent as a result of any future change impacting this area.

# Other Configurable Items Potentially Affected by Proposed Solution(s) (optional by BSCCo)

None. BSCP502 would only be impacted if the alternative clause in PSL130 (5.1.9) were required.
