<p>Title <i>(mandatory by originator)</i></p> <p>Incorporation of the authorisation of Originators for two SVA Processes within Code Subsidiary Documents</p>	
<p>Description of Change <i>(mandatory by originator)</i></p> <p>Modify BSCP38 so that it incorporates authorisations for the following two SVA processes:</p> <ol style="list-style-type: none"> 1) Provision of the Non Half Hourly (NHH) Balancing Mechanism (BM) Unit data. A Supplier will use this process if they choose to allocate NHH consumption to an Additional BM Unit(s); and 2) Provision of Supplier Volume Allocation (SVA) Line Loss Factor (LLF) data. The Public Distribution System Operator (PDSO) will use this process when they create LLF and require the LLF to be approved. 	
<p>Proposed Solution(s) <i>(mandatory by originator)</i></p> <ol style="list-style-type: none"> 1. BSCP38 Modify BSCP38 to include authorisation of the two SVA processes described above. This will require changes to: <ol style="list-style-type: none"> a) Section 1: This will need to cross-refer to BSCP507 and BSCP528. b) Section 4: Add one new row (relating to the BSCP507 authorisation) and modify row P (relating to the BSCP528 authorisation). c) Appendices: These will need to be modified to allow for authorisations relating to the two SVA processes. <p>There will be also be an impact on:</p> <ol style="list-style-type: none"> 1) BSCP507: A change will be required to Section 1 to require the Supplier to complete BSCP38 prior to providing the NHH BM Unit data to the SVAA for processing. 2) BSCP528: A change will be required to Section 1 to require the PDSO to complete BSCP38 prior to submitting LLFs for approval to the BSC Panel. <p>This proposal will impact the following Parties:</p> <ul style="list-style-type: none"> <input type="checkbox"/> Suppliers; and <input type="checkbox"/> PDSOs 	
<p>Justification for Change <i>(mandatory by originator)</i></p> <p>Ensures that changes to NHH BM Unit and SVA LLF data can only be provided from an Authorised Person.</p>	

Background

On 12th January 2000, TS2 (TS2/018/527) agreed to withdraw AP538 'Authorisation of Personnel Associated with Stage 2 Settlement' on the basis that the requirements within it would be incorporated within alternative Agreed Procedures. This Agreed Procedure was subsequently withdrawn from service. However, there are two SVA processes which do not have any authorisation associated with them. At present there is a risk that there may be unauthorised use of these processes.
