| <p>Description of Change <i>(mandatory by originator)</i> As a result of the “Supplier Stops Trading” walkthrough on 23 February 2001, it was agreed that a new step 3.2.7 should be incorporated into BSCP65 “Registration of Parties and Exit Procedures”, to ensure that when a Party changes their participation capacity from that of a Supplier they should be required to update Market Domain Data, via BSCP509 “Changes to Market Domain Data”.</p> | |

| <p>Justification for Change <i>(mandatory by originator)</i></p> <p>Implementing the change will ensure that an end date is set for the Supplier in the MDD. This is required to ensure that the Supplier does not continue to be registered in MDD and therefore cannot participate in the SVA trading arrangements.</p> <p>Not implementing the change may result in a Supplier being unaware of its obligation to update MDD when they are exiting the market and as a result will potentially allow the Supplier to trade in SVA.</p> | |
