BMRA BM Unit Identification

Description of Change (mandatory by originator)

This Change Proposal was originally raised as NETA Change Request NCR264.

The BMRA screens currently do not display sufficient information to allow participants to ascertain the market position. This CP proposes changes to enable users to:

- view the BM Unit registration data, to enable users of the service to identify and search on BM Unit information in which they have specific interest.
- enhance the single BM Unit selection facility in BMRS with a facility to select and sort displayed information by a variety of keys and selection criteria.

Proposed Solution(s) (mandatory by originator)**1) BM Unit Identification.**

- a) The majority of information currently displayed on the BMRS is referenced by BM Unit. Implement a BM Unit information search facility, which would allow users to more easily identify and access data on BM Units in which they have a specific interest.
- b) The information could be provided in a screen that detailed for each BM Unit:
 - i) Lead Party Name
 - ii) BM Unit Identifier
 - iii) BM Unit Type
 - iv) NGC BM Unit Name
 - v) National Grid Reference
 - vi) Zone Id
- c) The information should be downloadable in a standard CSV format.

2) BM Unit Selection Criteria

- a) Enhance the BM Unit Data reports in the BMRS to enable selection of data across multiple BM Units.
- b) Enhance the BM Unit Data reports to enable filtering and sorting of data according to a number of keys (see 1(b) above).
- c) Make the information downloadable in a standard CSV format.
- d) Any implementation of this facility should not impede the performance of the system due to the volume of data selected.
