| <p>Title <i>(mandatory by originator)</i> Modification to timesteps in BSCP28 to align them with timesteps in BSCP68.</p> | |
| <p>Description of Change <i>(mandatory by originator)</i> The addition of extra steps and different timescales in BSCP28, 'Approval and Notification of CVA Line Loss Factors'. These should be applicable only in the case of the approval of CVA Line Loss Factors for a Transfer of Registration from SMRS to CMRS, in order to bring the timing of BSCP28 in line with BSCP68, 'Transfer of Registration of Metering</p> | |
| <p>Proposed Solution(s) <i>(mandatory by originator)</i> Amend BSCP28 as follows:</p> <ul style="list-style-type: none"> • Change to the timetable in 3.1.1 to include 'or by 30 WD before "Effective From Date" in the case of Meter Transfers from SMRS to CMRS'. • Addition to 3.1.4 ACTION to specify 'In the case of Meter Registration Transfers, submit summary report form F28/01 Part C with recommendations for Panel Approval ex. Committee. Supply any additional information.' Corresponding addition to WHEN to read 'Within 3WD of ref (3.1.2) above.' • Add an additional step between 3.1.5 and 3.1.6 to say 'Within 10WD of 3.1.4, in the case of meter transfers, if no negative responses are received by transfer co-ordinator from the panel, then the Line Loss Factors are deemed agreed.' | |
| <p>Justification for Change <i>(mandatory by originator)</i> Paper ISG/11/102 was submitted to the ISG Meeting on 18/12/01. One of the recommendations of this paper was for the ISG to delegate the authority of LLF approval to ELEXON during the Meter Registration Transfer Process. This was not agreed; however ISG asked ELEXON to consider how to deal with similar situations in future. This Change Proposal addresses the ISG request. The suggested changes to BSCP28 are designed to allow the approval of LLFs for Meter Registration Transfers to occur within the timescales set out in BSCP68 for the Transfer of Registration of Metering Systems Between SMRS and CMRS.</p> <p>PMR 23447, 'BSCP20, BSCP28 and BSCP68' refers to the time difference in the submission of Line Loss Factors under BSCP28 and BSCP68.</p> | |
