<p>Title <i>(mandatory by originator)</i></p> <p>Meter Advance Reconciliation Results to PDSOs (BSCP05 & BSCP502)</p>	
<p>Description of Change <i>(mandatory by originator)</i></p> <p>BSCP05 v2.0 step 3.1.8 states that, if appropriate, the CDCA will notify the relevant DSOs of MAR reports, along with Registrants and MOAs. Similarly, step 3.4.1.2 of BSCP502 v3.0 states that HHDCs will send MAR reports to PDSOs in addition to Suppliers and MOAs if appropriate.</p> <p>The BSC does not explicitly require Distributors to be informed of MAR results by the CDCA and indeed, DSOs/PDSOs may not always want to receive such information. However, it is reasonable that the option should exist whereby DSOs/PDSOs can request MAR results from the CDCA/HHDCs if and when they want them.</p> <p>This CP supersedes CP624, which initially identified the inconsistency between the Code (section R6.2.1) and BSCP05.</p>	
<p>Proposed Solution(s) <i>(mandatory by originator)</i></p> <p>BSCP05 step 3.1.8: remove '(and if appropriate DSO)' and replace with 'DSO (if requested)'. BSCP502 step 3.4.1.2: in the 'To' box, remove the second paragraph which says 'Supplier, MOA and/or PDSO (as appropriate)' and replace with 'MOA and (if requested) PDSO'. The Supplier should continue to be a recipient of the flow.</p>	
<p>Justification for Change <i>(mandatory by originator)</i></p> <p>The BSC does not strictly require the issue of MAR Reports to Distributors, and no detailed advice has been given as to when such an action would be 'appropriate' or not. Sections R6.2 and S2.3 of the BSC state that MAR should be conducted according to BSCP05 and BSCP502 respectively.</p>	
<p>Other Configurable Items Potentially Affected by Proposed Solution(s) <i>(optional by BSCCo)</i></p> <p>The CDCA Service Description and the URS may need changing in order to align them with BSCP05 and BSCP502.</p>
