<p>The Archive and Restore software</p> <p>The changes to the software will address the following issues</p> <ol style="list-style-type: none"> <li>1. The deletion of Unix files is not recorded.</li> <li>2. The deletion of database records is recorded, but only for those tables that are audited.</li> <li>3. Database entries for files recorded with a status of deleted are not removed.</li> <li>4. Exception Reports from failed file loads are not cleared down by the archive.</li> <li>5. A number of database tables are not updated during an archive.</li> <li>6. A number of input data files, which do not relate to particular Settlement Dates, are not deleted by Archive and Restore. These include Line Loss Factors, Regression Equations, Profile Data, Pool Market Domain Data and Sunset Data.</li> <li>7. Currently the deletion of files used for defaulting is handled incorrectly</li> <li>8. The specification of the archive period is currently a fixed parameter within the software.</li> </ol>
