Title (mandatory by originator) Amendments to the SAA URS

Description of Change (mandatory by originator)

This Change Proposal has been raised to address inconsistencies initially identified by the NETA Programme and subsequently reviewed by ELEXON (IRP CP003).

Inconsistency BSCP_301_9:

Section 3.1.6 of BSCP301 version 2 (and N, 3.1.1 of the Code) state that the FAA will produce and distribute the authorised Payment Calendar no later than 31st January. Section I011 of the SAA URS version 2.4 has a date of 30th January.

Inconsistency BSCP_301_12:

BSCP301 version 2 sections 3.1.7-3.1.13 describe the timetable for the drafting, reviewing and publication of the Payment and Settlement Calendars. If the maximum time allowance is used, then there is a 22 Working Day gap between the distribution of the Payment Calendar by the FAA on 31st January and the publication of the Settlement Calendar by the SAA. However, the functional requirement SAA-F001 demands that the Settlement Calendar be published by 14th February, even though, according to the BSCP, the Calendar may still be under review.

Inconsistency SAA_01:

Section SAA-I006 of the SAA URS v.2.4 uses the old terminology of "Interconnector Deemed Metered Accounts" instead of "BM Unit Metered Volumes for Interconnector Users" as used in BSCP04.

Proposed Solution(s) (mandatory by originator)

Inconsistency BSCP_301_9:

The SAA URS should be altered to comply with BSCP301, otherwise the SAA will expect to receive the Payment Calendar a day later the defined and this could affect their operating schedule.

Inconsistency BSCP_301_12:

The SAA URS should be altered to comply with BSCP301.

Inconsistency SAA_01:

SAA URS terminology should align with BSCPs and the Code.

Justification for Change (mandatory by originator)

To remove inconsistencies between BSCP301 version 2, BSCP04 version 2, Code version 1.1 & SAA URS version 2.4.
