# Change Proposal – BSCP40/02 CP No: CP1467 Version No: (mandatory by BSCCo)

#### Title (mandatory by originator)

Inclusion of site ID data within the BSCP11/07 'TDC Trading Dispute Findings' form

#### **Description of Problem/Issue** (mandatory by originator)

The current Balancing and Settlement Code Procedure for Trading Disputes (BSCP11), 07 form does not include the site ID data (Metering System Identifier (MSID) / Balancing Mechanism Unit (BMU) / Energy Contract Volume Notification (ECVN) or Metered Volume Reallocation Notification (MVRN) Authorisation ID/Other IDs) relating to the Trading Dispute. The Registrant communication to its Agents with the instructions on rectification steps also does not always contain such information. This creates unnecessary delays in the process, whereby the Party Agents have to request the site ID data from the Supplier in order to proceed with the data amendments as stipulated in the Trading Disputes Committee (TDC) findings form.

### **Proposed Solution** (mandatory by originator)

The BSCP11/07 form will be amended to include a section on the site ID data (MSID / BM Unit / ECVN or MVRN Authorisation ID/Other IDs) relating to the Trading Dispute.

## **Justification for Change** (mandatory by originator)

Consultation responses for CP1459 highlighted that there would be a benefit in adding the site ID data within the BSCP11/07 form for the Registrant to provide this to all Party Agents when advising of any data amendments required as stipulated in the TDC Findings form. This would ensure the completeness and efficiency of the process for performing a Post-Final Settlement Run.
