Review of new and amended Configurable Items for Approved Modification P350

What is the purpose of this Circular?

This Circular invites you to review the new and amended Code Subsidiary Documents (CSD) and Configurable Items (CI) for P350 listed below and return any comment to ELEXON (<u>P350Implementation@elexon.co.uk</u>), using the form provided, by **17:00 on Friday 21 April 2017**.

Background

National Grid raised <u>P350 'Introduction of a seasonal Zonal Transmission Losses scheme'</u> on 4 July 2016. The <u>Draft</u> <u>Modification Report for P350</u> was presented to the Panel on 9 February 2017, who unanimously recommended that P350 it be approved. On 24 March 2017, Ofgem approved P350 for implementation on 1 April 2018.

Paragraph 1.3(g) of Annex T-2 of the P350 BSC changes allows changes to any CI required to facilitate the implementation of P350:

'this Annex T-2 shall take effect so as to require to be done anything necessary to be done before the Relevant Implementation Date of Modification P350 in order to give effect to this Annex T-2 with effect on and from the Relevant Implementation Date of Modification P350'

ELEXON realised that it would also need to start the procurement of the Transmission Loss Factor Agent (TLFA) BSC Agent and the Model Reviewer service provider in December 2016 to be able to deliver P350 in full on 1 April 2018; the Panel agreed to this approach when approving ELEXON's P350 Tender Framework Statement in December 2016 (confidential paper 261/13).

ELEXON developed draft versions of two new CSDs required for P350, for use in the Invitation to Tender for the TLFA in January 2017 and the approved versions of which will form part of the TLFA contract: the TLFA Service Description and the Load Flow Model Specification. ELEXON presented these draft versions to the Panel for information in March 2017 (Panel 264/10). ELEXON has also developed changes to several existing CSDs and CIs to give effect to P350. These documents, which are listed in the table on page 2, are now ready for your review.

What will happen after the industry review?

The new and amended CSDs and CIs will be updated to incorporate any reasonable comments.

The two new CSDs will be presented to the Panel for approval on 11 May 2017, with a proposed effective date of 12 May 2017, to allow the new TLFA to start work at the earliest opportunity after the Panel has approved the new TLFA (also at the May 2017 Panel meeting). The Panel will also be asked to delegate ownership of both documents to the Imbalance Settlement Group (ISG) as Category 2 (as defined in BSCP40) CSDs.

The amended CSDs and CIs will be presented to the relevant Panel Committees for approval in May 2017 with the proposed effective date of 29 June 2017 (the June 2017 Release implementation date).
