Purpose	This circular invites BSC participants to review changes to BSC Configurable Items to correct omissions from the approved set of documents amended for P344 as part of the February 2019 BSC Release.

Further review of BSC Configurable Items amended for the February 2019 BSC Release

What is the purpose of this Circular?

This circular invites the Balancing and Settlement Code (BSC) Parties and other interested parties to review and provide comments on changes to BSC Configurable Items (CIs) required to correct omissions from the set of BSC CIs approved for Approved Modification P344 <u>Project TERRE implementation into GB market arrangements</u> which will become effective on 28 February 2019 as part of the February 2019 BSC Release.

Background

We issued the BSC Configurable Items (CIs) amended for P344 for industry review via two Release Circulars; the first batch of BSC CIs was issued on <u>25 October 2018</u> and the second batch was issued on <u>2 November 2018</u>.

The Panel approved all of the BSC CIs amended for P344 at its special meeting (<u>Panel 284C/01</u>) on 28 November 2018.

However, during the process of reviewing the consolidated versions of the BSC CIs amended for the February 2019 Release, which also includes Approved Modification <u>P359 'Mechanised process for GC/DC declarations'</u> and approved Change Proposal <u>CP1510 'Allow the online management of registrations, Market Entry and Market Exit'</u>, we identified some omissions from the approved set of BSC CIs for P344:

- <u>SVA Data Catalogue Volume 1 Data Interfaces</u>: did not include four new data interfaces included in <u>Section</u> <u>3.2A of BSCP508 'Supplier Volume Allocation Agent'</u>; and
- <u>SVA Data Catalogue Volume 2 Data Items</u>: did not include the new data items included in the four new data flows.

We have taken the opportunity to correct some other minor errors at the same time.
