What is the purpose of this Circular?

This circular notifies interested parties of the latest working versions of the Interface Definition and Design (IDD) Part 1 and Part 2 spreadsheets for project TERRE.

Please note that ELEXON has not issued these versions formally for industry consultation and they are still subject to changes. The spreadsheets have been made available for use by Virtual Lead Parties (VLPs) and other Balancing and Settlement Code (BSC) Parties to develop or amend their systems in readiness for Project TERRE implementation.

Background

On 5 April 2019, ELEXON shared copies of the IDD spreadsheets to support the GB Electricity Industry with their initial preparations for Project TERRE. Since then, there has been an update to the spreadsheets.

When will the IDD Spreadsheets be approved?

The BSC changes for P344 'Project TERRE implementation into GB market arrangements', which was implemented on 28 February 2019, did not make allowance for any BSC Configurable Items (CIs) that could not be implemented on the P344 implementation date (with the exception of a new BSCP603).

As a result, we are raising a separate Change Proposal to cover all other BSC CIs that need to become effective on the P344 Final Implementation Date to deliver project TERRE in full.

The IDD Part 1 and Part 2 spreadsheets amended for the full TERRE solution will be included in the scope of this CP and will be taken to the Imbalance Settlement Group (ISG) for approval in summer 2019.

What do I need to do?

Please use these versions of the IDD spreadsheets to develop your systems to be ready for TERRE implementation. While they have not been approved yet and could change before approval, ELEXON believes that any such changes would be small, and should not prevent VLPs or other BSC Parties from developing their systems against these versions.
