Purpose This circular invites interested parties to review draft versions of the BSC Configurable Items that have been amended for approved CP1517 for Wider Market Access and Project TERRE

What is the purpose of this Circular?

The purpose of this circular is to invite interested parties to review the draft versions of the Category 2 BSC Configurable Items (CIs) that we are amending under CP1517 to give full effect to P344 Final Implementation.

Background

Change Proposal [CP1517](#) was raised to allow changes to BSC Configurable Items relating to the full solution to Wider Market Access and TERRE to be aligned to the date set in the P344 Final Implementation Date Notice, as described on the '[GB Wider Access and Terre Implementation Guidance](#)' page of the ELEXON website. All Category 1 BSC CIs were approved when CP1517 was approved by the Imbalance Settlement Group on 20 August 2019 (ISG220/01) and by the Supplier Volume Allocation Group on 3 September (SVG223/03).

The Category 2 BSC CIs amended for CP1517 were not developed with CP1517 but they have now been developed and are available for industry review.
