Implementation of the November 2019 Release

What is the purpose of this Circular?

This Release Circular confirms the changes to Code Subsidiary Documents (CSDs) that we will implement for the November 2019 BSC Release ('the Release') on 07 November 2019.

What changes are delivered by the Release?

The table below shows the changes to be implemented on 7 November 2019.

How will the changes affect me?

- **P386** corrects the errors in the P344 legal text as well as provide clarification when the WA and TERRE product goes live, and all BSC obligations become active. This modification does not impact any BSC Party or Party Agents. There is no impact on BSC Systems.
- **P387** amends the Balancing and Settlement Code (BSC) Panel Elections process to allow communications between parties via email as well as other methods to be approved by the BSC Panel on a case-by-case basis. This modification does not impact any BSC Party or Party Agents. There is no impact on BSC Systems.
- P389 deletes BSC Section K3.1.8 (b). This will remove conflict and ambiguity between the BSC and Capacity Market rules without affecting either. This modification impacts Capacity Market Participants (Capacity Providers) and Suppliers.
